## Introduction

EGC 812 - Behaviour Modificationisa semester, two-credit unit course. It is a course for students of Masters Degree in Education Guidance and Counselling programme. ## How to Get the Most from This Course

In Open and Distance Learning (ODL), the study units replace the university lecturer. This is one of the great advantages of ODL. You can read and work through specially designed study materials at your own pace, and at a time and place that suit you best. Think of it as reading the lecturer.
